## **Key Responsibilities**

 Works with Tumuaki and Head of Equity to drive system change within the College and its training programmes to address inequities.

- Maintain effective working relationships with Lead Medical Educators in the Northern Region to ensure;
  - They receive the direction, support and feedback required in their education roles and are empowered to provide the support to medical educators, small group facilitators, teachers, and registrars in their regions
  - There are systems and processes are in place to identify at risk Registrars and apply appropriate pastoral support and assessment
  - o There is consistency in learning, delivery, and support across all regions for GPEP
- Maintain a supportive and collaborative working relationship with the Clinical Lead GPEP Southern to
  ensure consistency of approach, processes, and delivery of GPEP including escalation of any issues or
  risks to the successful delivery of the programme
- Provide support and input as required, to the Clinical Lead GPEP Southern to ensure the GPEP learning materials, planning, delivery and approach to the programme;
  - Provides learners with the opportunity to develop appropriate knowledge, skills, and attitudes for general practice
  - Applies best practice content and delivery including awareness of trends in general practice education both nationally and internationally
  - o Has learning materials that are fit for purpose and regularly reviewed and moderated

- Contribute to the optimisation of the GPEP programme budgeting by utilising sound technology solutions for learning and meeting activities including virtual attendance and presentation when practical

- > Experience in using technology as an enabler for learning delivery
