

COLLEGE CONFERENCE REGISTRATION TERMS AND CONDITIONS

1. CANCELLATIONS

Should you need to cancel your registration, you may reassign your registration to another person. Please notify the Royal New Zealand College of General Practitioners ("RNZCGP") or its agent ("Conference Innovators") in writing. If you are unable to arrange a replacement, a full refund less an administration charge of \$150.00 will be made provided notification is received at least 30 days before the conference. After this date, refunds will be at the discretion of RNZCGP. If, for reasons beyond the control of RNZCGP or for reasons of delegate health and safety, the conference is cancelled, then the registration fee will be refunded after deduction of expenses already incurred by RNZCGP.

2. CONDITIONS

RNZCGP (and Conference Innovators as RNZCGP's agent) reserves the right to deny entry and/or terminate the registration of any person who demonstrates behaviour that is deemed to be inappropriate and/or a risk to others.
